Council Member – China Road Federation, Taiwan

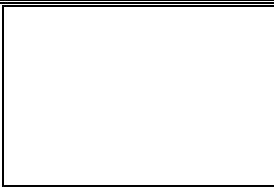

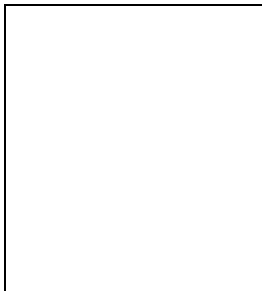

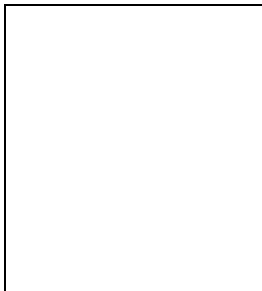
